We currently have a number of graduates preparing to sit their Assessment of Professional Competence (APC) and Central Association of Agricultural Valuers (CAAV) exams.

The Firm offers a structured training programme to enable graduates to complete their chartered surveying qualifications (APC). This includes iSurv subscription access, internal training away days (several of which take place on site farm visits).

We provide this full support throughout the training process by arranging update meetings, presentation training and mock interviews with past examiners. With a number of candidates passing the exams each year, a natural training support mechanism has been created. We cover all training costs, attendance to RICS and CAAV training seminars, RICS Matrix and External events are encouraged.





GRADUATE TRAINING AND DEVELOPMENT PROGRAMME

Brown&Co aims to recruit and retain the best employees and provide the necessary training and development opportunities to maximize their performance and develop a long-term career with the Firm.

To provide the highest possible standards of service to our clients, we are committed to investment in these areas and provide a wide range of technical and skills based courses to our employees.
